

ORDINANCE NO. #121

AN ORDINANCE CREATING A HOOK-UP FEE FOR NEW HOOK-UPS TO THE CITY OF PECK WATER SYSTEM AND PROVIDING THAT THE OWNER OF THE PROPERTY PAY FOR THE COSTS OF THE INSTALLATION AND THE WATER LINE FROM THE CITY TAP TO THE WATER METER AND PROVIDING AN EFFECTIVE DATE:

WHEREAS, the City of Peck is the owner of the water distribution system in the City of Peck and,

WHEREAS, from time to time there are requests for new services on said water system.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF PECK, IDAHO, AS FOLLOWS:

Section 1: That a charge of THIRTEEN HUNDRED AND FIFTY DOLLARS (\$1,350.00) for any hook-up after the effective date of this ordinance to the Peck water system. That the sum of THIRTEEN HUNDRED AND FIFTY DOLLARS (\$1,350.00) shall include the taping fee on the City water line, the meter, and the box, but that in addition to the amount of THIRTEEN HUNDRED AND FIFTY DOLLARS (\$1,350.00) the property owner will reimburse the City of Peck for putting the line in from the tap to the water meter. This line to the water meter to the tap cannot be done by the property owner but must be done by the City and the City must be reimbursed by the property owner. It shall further be the cost of the property owner to put the line from the meter to the property owner's home.

Section 2: That this ordinance shall take effect and be enforced from and after its passage, approval and publication.
