

ORDINANCE No. 81

AN ORDINANCE VACATING WASKEY STREET BETWEEN RATCLIFF STREET AND MAIN STREET, BEING BETWEEN BLOCKS 37 and 46 and BLOCKS 36 and 47 OF THE CITY OF PECK, IDAHO, TO THE ABUTTING PROPERTY OWNERS; DIRECTING THE CITY CLERK TO CAUSE A CERTIFIED COPY OF THIS ORDINANCE TO BE RECORDED AT THE OFFICE OF THE RECORDER OF NEZ PERCE COUNTY, IDAHO; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the owners of the real property abutting Waskey Street between Ratcliff Street and Main Street, between Blocks 37 and 46 and 36 and 47 of the City of Peck, Idaho, having petitioned the City of Peck Council to vacate said street and,

WHEREAS, a public hearing on said petition was held on April 7, 1980 and written notice of said public hearing was posted in three (3) places at least ten (10) days prior to said public hearing, such notice was published once a week for two (2) consecutive weeks in the official newspaper of the City, the last publication not being less than seven (7) days prior to the date of said hearing, and

WHEREAS, it is the determination of the Peck City Council that it is in the best interest of the City of Peck and its inhabitants and of the property abutting said street, particularly described in Section 1 below, that said street be vacated as a public street of the City of Peck.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF PECK, IDAHO, AS FOLLOWS:

Section 1: That the following street in the City of Peck, Nez Perce County, Idaho, particularly described as follows:

Waskey Street between Ratcliff Street and Main Street
being between Blocks 37 and 46 and Blocks 36 and 47,

~~be and the same are hereby vacated as a public street of the City~~
of Peck, Idaho, and that said street shall revert to the owners of the adjacent real property.

Section 2: That the City Clerk be and is hereby authorized

and directed to cause a certified copy of this ordinance to be recorded at the office of the Recorder of Nez Perce County, Idaho.

Section 3: That the Mayor and the City Clerk be and are hereby authorized to execute and deliver, upon request therefor, a quitclaim deed in and to the City's interest in said street to the abutting property owners, as their respective rights may appear.

Section 4: This ordinance shall take effect and be in force from and after its passage, approval and publication.
